#### 2015-17 Program Planning Meeting

Saturday, March 1 members of the League attended a bi-ennial Program Planning Meeting at the Great Wall chinese restaurant on East State Street.

The purpose of the session is to make recommendations to the State League regarding positions the state has taken on various subjects. More information regarding these positions are available from: http://www.lwvil.org/convention-2015-program-planning.html

Subjects studied were:

#### **Representative Government:**

Constitutional Implementation, County Government Structure, State Election Laws, Registration & Elections, State Board of Elections, Election Systems Criteria, Term Limits, State Redistricting.

#### **Natural Resources:**


Illinois Land Use Policies, Comprehensive Policy, Low/ Moderate Income Housing, Development Impact Fees, Large-Scale Livestock Facilities, Pesticides, Water.

#### **Social Policy:**

Children's Services, Criminal Justice, Death Penalty Abolition, Gun Violence Prevention, Handgun Control, Assault Weapons Control, Immigration, Income Assistance, Mental Health, Schools, School Quality, School Finance, Charter Schools, State Fiscal Policies, Statement on Gambling.

All positions were retained except Redistricting, which was decided as "Restudy/Update."

#### Campaign Finance Reform

LWVGR's campaign finance reform committee met in January. Jessica Jones of the National League of Women Voters outlined the four things that the League will be working on in the coming year.

#### **Improve Disclosure:**

Supreme Court Justice Anthony Kennedy said: "Disclosure permits citizens and shareholders to react to the speech of corporate entities in a proper way." Citizens have a right to know who is trying to influence their vote and disclosure of donations and spending is necessary to shine a light on secret money. The League is a longtime supporter of the DISCLOSE Act and we will continue to push for passage of this important piece of legislation.

#### **Establish a Public Financing System:**

The League believes that public financing is the best long term solution to getting big money out of politics. States like Arizona, Connecticut and Maine have had success in public financing with state house and statewide elections. The League continues to look for ways to limit the size and type of contributions from all sources as a means of combating undue influence in the election process.

#### **Strengthen Regulations on Coordination:**

The Federal Election Commission (FEC) is the federal agency in charge of our nation's campaign finance laws, but so far they've done practically nothing to address the U.S. Supreme Court's disappointing decision in Citizens United. Under existing law, the FEC can work to define "coordination" as a way of cutting back on the "independent" expenditures that really are coordinated with candidate campaigns, but thus far they have refused to do so.

#### Vote:

If the American public wants to get money out of politics, it's time to take our elections back. Voting is the most powerful form of expression that a single citizen



has. When citizens vote, politicians have to listen. We must improve voter turnout and engage within our communities to combat the undue influence of money in our political system.

Our local committee is closely following the efforts of the League, Illinois Campaign for Political Reform, and Common Cause Illinois in their efforts to establish small donor democracy (aka public financing) systems for Chicago, Evanston, and Oak Park. We are working with the Illinois Campaign for Political Reform to determine the viability of such a system here in Rockford. In February 79% of Chicago voters gave their support to this idea in an advisory ballot question. Voters in Winnebago and DeKalb Counties will have the opportunity to weigh in on a similar idea on their April 7th ballots.

Our members have a lot to learn about public financing systems; how they are operated and how they are funded. We welcome all League members to help us explore this exciting area. Our next meeting is March 17th at 6pm at Meg's Daily Grind, 3885 N Perryville Rd, Rockford. We meet there the third Tuesday of every month. We hope to see you.
