



As you may be aware, LWVGR operates on a fiscal year from July 2022 to June 2023. Member dues are collected every June. As always, you may pay online by going to <https://lwvgr.org/join/>

For the first time, you may opt-in to arrange an automatic renewal of your credit/debit card-paid membership dues. If you opt-in, every June you will be notified by email that your annual LWVGR membership dues will be automatically charged to the credit card you have on file. You may opt-out from automatic payment at any time.

Why is LWVGR offering this option? For many of us, our lives are busy, our computer email inboxes are overflowing, things get lost. Automatic renewal is meant to be a convenience for you as well as save the League the time and expense of sending paper reminders which allows dues collected to be used for programming rather than postage.

Another thing to consider if paying on-line: Whether you choose to pay yearly or choose the automatic payment system, you may also opt to pay for PayPal's transaction fees so that 100% of your dues goes to LWVGR to assist in its work. PayPal collects a 3.49% processing fee plus a \$0.49 transaction fee. LWVIL and LWVUS is allocated \$64 of your dues. Question? Contact Treasurer Chis Hiltrop at billing@lwvgr.org.
